Seller, hereby retains a security interest in all materials and services purchased by customer under this agreement to secure payment of the same, and all delivery tickets and invoices pertaining to sales by seller to all incorporated herein sell items purchased under this agreement in accordance with the applicable provisions of the TEXAS BUSINESS COMMERCE CODE or other laws governing jurisdictions outside the State of Texas.
- E. All payments agreed to under this agreement shall be paid to seller at its offices located in Carrollton, TX, the county of Dallas.
- F. Customer hereby authorized all companies and financial institutions to release credit information to seller.

The foregoing application for credit and credit agreement has been completed for the purpose of securing credit from seller, and the undersigned hereby acknowledges and warrants the truthfulness and accuracy of the information herein provided and the customer's financial ability to comply with the credit agreement.
